\*Two (2) tickets for rodeo(s) will be issued per booth for each day you reserve at the rodeo grounds. You will need to purchase additional tickets for workers in your booth, or your children, by indicating below and adding \$\_\_\_\_\_/ticket. Children under 6 are free.

**Rules:** Set up 4pm Friday for Friday night rental, 8am Saturday or Sunday for rental those days, or at least 1 hour prior to the start of RVCR event. You are responsible for tables, chairs, canopies, etc. and securing them after closing if rental all weekend. There will not be security provided. All trash must be removed and placed in appropriate disposal/recycle containers on site each day. All vehicles must be removed from vendor areas and parked in appropriate parking lot 1 hour prior to the start of RVCR sanctioned event. Absolutely no sales of alcohol or illegal substances, or use of illegal substances permitted by vendors at any RVCR event. Follow local tobacco ordinances, food safety ordinances, and common courtesy. Make sure all open flames/gas cannisters properly secured to prevent fire/other hazards. Vendor is responsible for any permits necessary or submission of CA sales tax as required by their product sales. Vendor is responsible for the activities of their associates/workers. Vendors/workers may be asked to leave for disruptive/dangerous behavior. Rental fees/extra tickets are non-refundable.
